Planting & Compliance

Hip Hip Horray! Spring is here!

As planting season fast approaches, so does crop insurance! Sales Closing Date of March 15th has come and gone, upcoming dates are as follows:

- Earliest Planting of Corn-April 10th
- Earliest Planting of Beans-April 25th
- Final Plant Date of Corn-May 25th
- Hail Coverage Deadline-June 1st
- Final Plant Date of Beans-June 10th
- Late Planting of Corn-June 14th
- Late Planting of Beans-July 5th

As planting begins, remember to report your acres to Agency One Insurance by **July 15th**. Certify acres at your local FSA prior to this date and bring that information to us. This allows us to complete acreage reporting.

AD 1026 Compliance: Remember the importance of being compliant and completing your paperwork properly at your local FSA office,

affects your subsidy premium.

Key things to remember when being compliant:

- Name of Individuals or Entity need to be the same for FSA, Insurance, and Grain Sales.
- Verifying ID #'s, making sure ID numbers match FSA and Insurance.
